Hughes Justice Complex, Trenton, New Jersey 08625 or by visiting the website at www.judiciary.state.nj.us/taxcourt/

Restatement appeals must be filed on or before April 1 of the current tax year or 45 days from the date mailed or it appears on the front of this notice, whichever date is later.

ADDITIONAL INSTRUCTIONS:

Do not multiply last year's property tax rate by the current year's assessed value to determine taxes for the current year.
